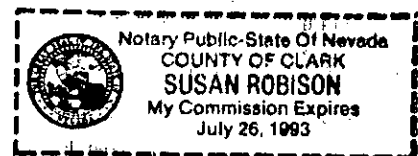

CONTRIBUTIONS
