

## **ELECTRONIC MONITORING/ HOUSE ARREST NOTICE**

### **PROGRAM REQUIREMENTS**

- 1. You are required to IMMEDIATELY report to the Henderson Special Programs and Services after leaving court. The Special Programs and Services Office is located in the basement of the courthouse. If you fail to immediately report, you will be subject to immediate arrest for a new charge of a Probation Violation under NRS 211A. If SPS is unable to locate you, a warrant will be requested for your arrest.**
- 2. The House Arrest Program costs \$15.00 per day with an initial setup fee of \$75.00. Payment of the setup fee is required at the time of enrollment. You may pay with Cash, Credit Card, Debit Card or Money Order. If you have any questions about making payments, you can discuss that during your intake process. Your ability to pay for the House Arrest Program will be considered at the time of intake. If it is determined that you are unable to pay for the Program, you will be returned to the Sentencing Court for further action.**
- 3. You will be required to sign and agree to *The House Arrest Program Agreement and Rules*. If you fail to agree to or sign these rules, you will be immediately taken into custody and returned to The Henderson Detention Center to serve out the remainder of your sentence as specified in your sentencing order.**

### **NOTICE OF D.A.R.T. AND C.A.T PROGRAM REQUIREMENTS**

- 1. IF ORDERED IN COURT TO Special Programs and Services D.A.R.T./C.A.T. PROGRAM, YOU ARE REQUIRED TO IMMEDIATELY REPORT TO THE Special Programs and Services AFTER LEAVING COURT.**
- 2. THE D.A.R.T. PROGRAM COSTS \$25.00 PER WEEK ORDERED TO TESTING. THE C.A.T. PROGRAM COSTS 75.00 PER WEEK ORDERED TO TESTING. PAYMENT IS DUE AT THE TIME OF THE TEST, BUT PAYMENT ARRANGEMENTS MAY BE MADE. IF A DRUG TEST IS PRESUMPTIVELY POSITIVE AND YOU DENY ANY USE, A \$30.00 CONFIRMATION FEE WILL BE ASSESSED FOR SENDING IT TO THE LABORATORY. YOU MAY PAY WITH CASH, CREDIT CARD, DEBIT CARD OR MONEY ORDER DURING NORMAL BUSINESS HOURS (MONDAY-THURSDAY 7:30AM TO 5PM).**
- 3. THE D.A.R.T./C.A.T. PROGRAM UTILIZES DIRECT OBSERVATION URINALYSIS AND INDEPENDENT LABORATORY CONFIRMATION.**
- 4. PROGRAM PARTICIPANTS ARE REQUIRED TO CALL IN AND LISTEN TO A PRE-RECORDED TELEPHONE MESSAGE DAILY TO SEE IF THEY ARE BEING TESTED THE FOLLOWING DAY.**
- 5. D.A.R.T. PROGRAM TESTING REQUIRES ON-SITE TESTING AT PREDETERMINED TIMES.**
- 6. A SIGNED WRITTEN AGREEMENT WILL BE REQUIRED IN ORDER TO PARTICIPATE IN THE D.A.R.T./C.A.T. PROGRAM. THIS AGREEMENT COVERS ALL OF THE D.A.R.T./C.A.T. PROGRAM REQUIREMENTS.**
- 7. PRESCRIPTION MEDICATION WILL BE VERIFIED EACH TIME YOU ARE TESTED AND YOU MUST BRING ALL MEDICATIONS WITH YOU TO THE TESTING FACILITY FOR VERIFICATION.**
