

AN ORDINANCE TO ADOPT VARIOUS CODES, SCHEDULES AND STANDARDS RELATING TO FIRE PREVENTION AND FIRE PROTECTION, AND TO REPEAL SECTION 3 OF ORDINANCE NO. 83 ENTITLED "AN ORDINANCE PROVIDING FOR RULES AND REGULATIONS GOVERNING CONDITIONS HAZARDOUS TO LIFE AND PROPERTY FROM FIRE: PROVIDING PENALTIES FOR THE VIOLATION THEREOF, AND PROVIDING FOR ALL OTHER MATTERS PROPERLY RELATED THERETO", CODIFIED AS CHAPTER 15.32.030 OF THE HENDERSON MUNICIPAL CODE.

THE CITY COUNCIL OF THE CITY OF HENDERSON, NEVADA, DO ORDAIN AS FOLLOWS:

SECTION 1:

(HMC 15.32.030) Code Standards and Schedules adopted by reference:

The following codes, standards, and schedules are by this reference hereby adopted as part of the Henderson City Fire Prevention and Fire Safety Ordinance, Chapter 15.32 of Henderson Municipal Code:

- A. National Fire Codes - 10 volumes published by the National Fire Protection Association - 1968-1969 Edition.
- B. Fire Protection Handbook - Twelfth Edition 1962 Published by National Fire Prevention Association.
- C. Fire Prevention Code - 1965 Edition as recommended by the American Insurance Association, successor to the Nation Board of Fire Underwriters, including the October 1966 revision of the Fire Prevention Code 1965 Edition.
- D. Standard Schedule for grading cities and towns of the United States with reference to fire defenses and physical conditions as published by the National Board of Fire Underwriters 1956 Edition.

SECTION 2: Repeal of Certain Provisions:

Section 3 of Ordinance No. 83, and the corresponding portion of the Henderson Municipal Code codified as Chapter 15.32.030, which provides as follows:

"The rules and regulations of the following standards are hereby adopted by reference and hereby made a part hereof:


- A. Standards of the National Fire Protection Association.
- B. Standards of the National Board of Fire Underwriters.
- C. Standards of the National Board of Fire Underwriters, Fire Prevention Code.
- D. Standards of the National Underwriters Laboratories."

is hereby repealed.


SECTION 3:




