

ORDINANCE NO. 3709
(Amend Henderson Municipal Code Chapter 2.04 – Council Meetings)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HENDERSON,
NEVADA, TO AMEND CHAPTER 2.04 - COUNCIL MEETINGS - OF THE
HENDERSON MUNICIPAL CODE.

- WHEREAS, Section 2.060 of the City Charter allows the City Council to fix the time and place of its meetings; and
- WHEREAS, Ordinance 1415 was adopted July 20, 1993; and
- WHEREAS, Ordinance 2961 was adopted April 3, 2012; and
- WHEREAS, Ordinance 3174 was adopted June 17, 2014; and
- WHEREAS, Ordinance 3368 was adopted November 1, 2016; and
- WHEREAS, City Council desires to have flexibility in its ability to schedule the time for its meetings to maximize public participation in its meetings; and
- WHEREAS, the City supports efforts to mitigate overtime staffing costs by commencing the City Council meetings during regular working hours for the majority of City staff; and

NOW, THEREFORE, the City Council of the City of Henderson, Nevada, does ordain:

SECTION 1. Chapter 2.04 Council Meetings is hereby amended as follows:

Section:
2.04.010 - Date and time of meetings

The city council shall meet in regular session [at 6:00 p.m.,] on the first and third Tuesday of each month at a time to be determined and published consistent with NRS chapter 241. The city council may, as it deems necessary, schedule a regular meeting on a date other than the first or third Tuesday of each month, in accordance with sections 2.040 through 2.060 of the City of Henderson Charter and the provisions of NRS chapter 241.

SECTION 2. The effective date of this ordinance shall be July 10, 2020.

SECTION 3. If any section, subsection, paragraph, clause or provision of this Ordinance shall for any reason be held invalid or unenforceable, the invalidity or unenforceability of such section or subsection, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

SECTION 4. All ordinances, or parts of ordinances, sections, subsection, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Henderson, Nevada, in conflict herewith are repealed and replaced as appropriate.

SECTION 5. A copy of this Ordinance shall be filed with the office of the City Clerk, and notice of such filing shall be published once by title in the Las Vegas Review-Journal, a newspaper having general circulation in the City of Henderson, at least ten (10) days prior to the adoption of said Ordinance (Initial Publication). Following adoption by the City Council, this Ordinance shall be published by title together with the names of the Council members voting for or against passage (Final Publication). This Ordinance is scheduled for Final Publication on July 10, 2020, in the Las Vegas Review-Journal, at which time it will become effective.



“COUNCIL AS A WHOLE”


