Guidelines and Application

Early Childhood Education Scholarship Program

This Program is funded by the City of Henderson Redevelopment Agency Public Education Set-Aside Fund to increase access to Early Childhood Education for students that reside in the Eastside or Downtown Redevelopment Areas. This scholarship is only valid at the state licensed preschool programs, ABC ETC. and Little Learners, administered by the City of Henderson Parks & Recreation Department. Scholarship funds will be provided to students that otherwise could not participate due to financial burden or hardship. ALL SCHOLARSHIP FUNDS WILL BE DISPERSED DIRECTLY TO THE PRESCHOOL PROGRAM.

This Program is available to eligible students residing in either the Downtown or Eastside Redevelopment Areas. Program scholarships are for the enrollment in and attendance to the preschool program(s) offered by the City of Henderson Parks & Recreation Department at the Valley View Recreation Center, when the applicant can demonstrate that no other reasonable means of financing student participation is available. Approval, denial, or modification lies with the Executive Director of the Redevelopment Agency or his designee. Should a recipient wish to appeal the decision of the Executive Director, staff will promptly schedule the appeal to be considered by the Redevelopment Agency Board at a regular meeting of the board.

I. PRESCHOOL SCHOLARSHIP ELIGIBILITY

This Program provides scholarship assistance from the City of Henderson Redevelopment Agency Public Education Set Aside Fund to fund 50% of the preschool enrollment costs offered at the Valley View Recreation Center on a per student, per semester increment. Funding will be provided for registration on a semester schedule and scholarship recipients must maintain a 90% attendance rate each semester to be eligible for scholarship funding in subsequent semesters. All requests for scholarship assistance must be in writing and submitted to the Redevelopment Agency on the application form included in this packet. All requests for assistance will be reviewed and awarded by the Redevelopment Agency, subject to funding availability. Scholarship awards will be referred to, applied and processed by the City of Henderson Parks & Recreation Department—Youth Enrichment division.

CRITERIA

- Scholarship program applicants must meet all requirements for preschool students as established by the City of Henderson Parks & Recreation state licensed Preschool Program Enrollment Requirements (see Preschool Parent Handbook).**
- Student must reside in the Downtown (Appendix “A”) or Eastside (Appendix “B”) Redevelopment Area – proof of residency required.
- Scholarship award funding to be provided directly to the City of Henderson Parks & Recreation Department and applied to the participants preschool program enrollment account.
- 90% student attendance rate must be maintained for future scholarship eligibility. Attendance record to be verified by Agency staff with P&R staff at semester conclusion.
- Applicants must provide a statement of financial need/hardship.
- Incentive of full annual scholarship credit if annual enrollment fee is paid in full in accordance with Parks & Recreation annual payment due date.

II. APPLICATION PROCESS

- a) To submit a preschool scholarship application packet, please contact the City of Henderson Redevelopment Agency at 702-267-1515, Monday through Thursday, 7:30 a.m. – 5:30 p.m., to schedule an appointment with Agency staff.
- b) After a complete application packet has been received, the application will be reviewed by Agency staff.
- c) Include proof of residency.
- d) Include statement of financial need/hardship.
- e) Scholarship recipient will be notified of award status and interdepartmental notifications will be updated.

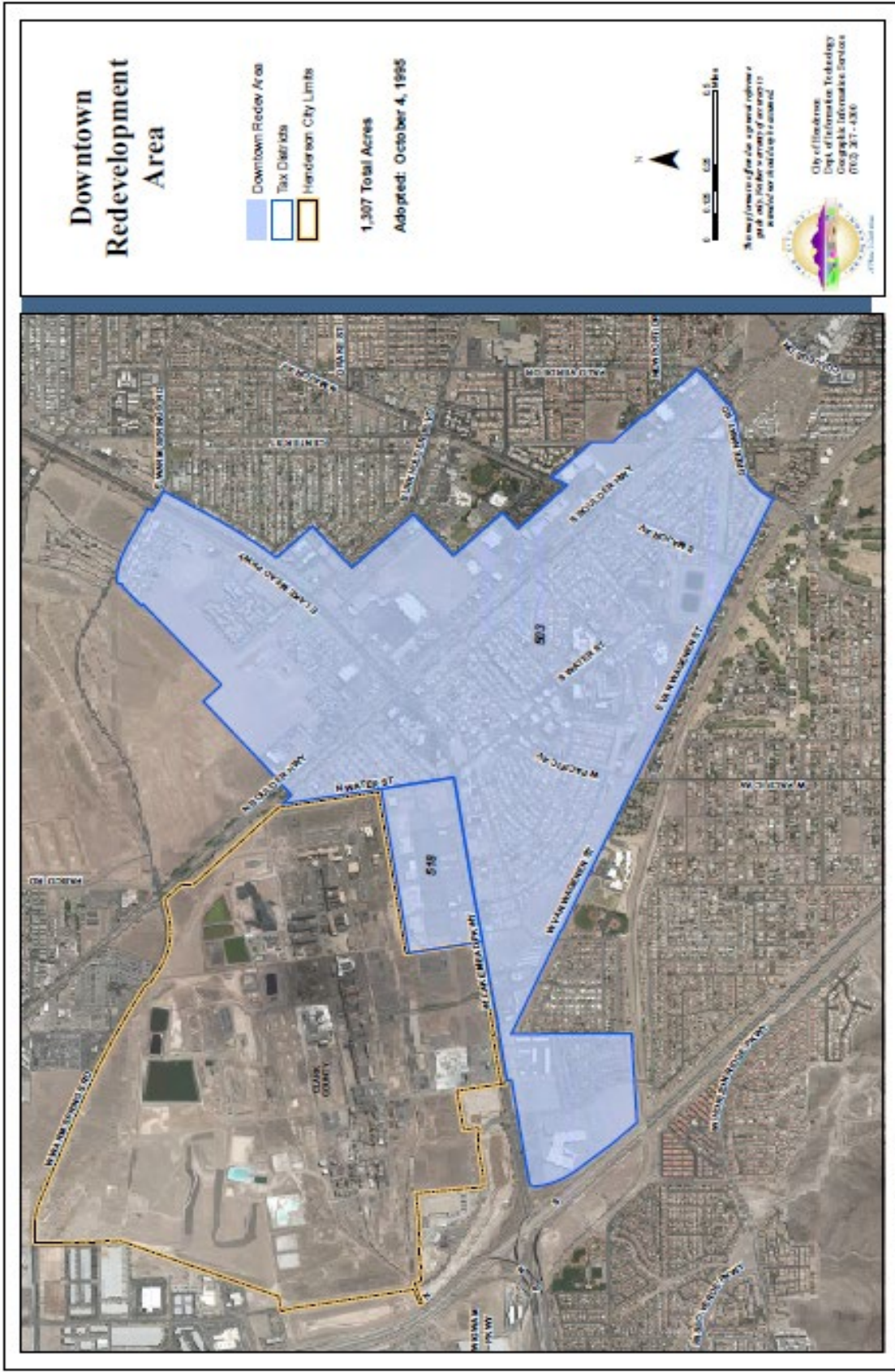
